In March 2016, Sonboly communicated with William Atchison, the gunman who perpetrated the school shooting at Aztec High School in Aztec, New Mexico on December 7, 2017. Sonboly and Atchison communicated through the online gaming platform Steam. Atchison also communicated with a German teenager, David Forster, who was arrested by German authorities on July 24, 2016, in connection with plans regarding a separate school shooting. I request records of the FBI's investigation of William Atchison that refer Sonboly, Forster, the online gaming platform, Steam, and several alias used on the Steam gaming platform.

- 1. All FBI records of the FBI's investigation of William Atchison that mention Ali David Sonboly;
- 2. All FBI records of the FBI's investigation of William Atchison that mention David Forster;
